ATTORNEY FIGHTS JUDICIAL CORRUPTION FROM JAIL

Los Angeles, CA A prominent 70 year old former U.S. prosecutor, Dr. **Richard I. Fine** is serving well into his second year of solitary, "Coercive Confinement" in L A County jail. His crime? He attempted to disqualify a Judge who had admitted to taking illegal payments from a party involved in the case before him. That party was the County of L.A. where the Judges were always ruling in favor of the County as Fine reveals in his court documents. State Superior Court Judges had been receiving over \$300 million in illegal payments from the county and since 2005 all but three cases were decided in favor of the county.

JUDICIAL OBSTRUCTION OF JUSTICE SCHEME

Richard Fine sets forth in a letter, demanding State and Federal Grand Jury investigations, addressed to U.S. Attorney General **Eric Holder**, L.A. District Attorney **Steve Cooley**, State Attorney General **Edmund G. Brown, Jr.**, and U.S. Attorney **Andre Birotte, Jr.** that State Superior Court Judges have been Obstructing Justice for years. He documents numerous cases citing Judges and the County's illegal payments as having been obstructing justice. Including one such case where State Superior Court Judge David P. Yaffe admitted in Court (have transcript) to taking illegal payments and in his own Court Order to having lied to the higher courts regarding his ruling against Fine.
