Re: Request for Investigation of HUD; Attorney-Advisor Edward J. Campbell

Dear Mr. Birotte:

This formal complaint is submitted to the **Federal Bureau of Investigation** with a request for an immediate investigation of Edward J. Campbell, Office of General Counsel with the U. S. Department of Housing and Urban Development, Los Angeles Area Office, at 611 West 6<sup>th</sup> Street, Suite 801, Los Angeles.

It has come to my attention in a June 9, 2001 letter signed by Edward J. Campbell ([Attachment 1](#)) conducting a “cover-up” campaign to intimidate citizens from exercising their Constitutional right to access and disseminate public documents and in doing so is facilitating the destruction and or altering of Federal documents that are public records.

As an American citizen and concerned property owner in Marina del Rey, I have the right to disseminate public information for the purpose of informing the community on issues that will greatly impact the fiscal stability of our country, state and community. And I we as citizens have the right to inform our fellow citizens of government actions that may pose a threat to our personal safety and private property.

Mr. Campbell’s letter is covering up the fact that (1) developer Jerry Epstein was previously involved in a bankruptcy which was not reported to HUD as he sought and obtained a HUD loan to develop The Shores, a luxury apartment complex in Marina del Rey, California, and (2) that all of the Los Angeles County permits given to Mr. Epstein are illegal because they were voted on (and approved) within twelve months of receipt of campaign contributions given by Jerry Epstein, his wife Pat Epstein, the Epstein Family Trust, and Jerry Epstein's "Chief of Staff" David O. Levine, to Los Angeles County Supervisors. The contributions and subsequent votes were also not disclosed to, or by, HUD, despite these facts having been shown and being made available in public records in the case of *Marina Strand Colony II Homeowners Association v. County of Los Angeles*, LASC Case No. BS 109420, and the contribution records being made public on the Los Angeles County Recorder/Registrar's website.

The documents that Edward Campbell claimed were “private” and ordered citizens to immediately destroyed were clearly in the public domain. Attached here is a letter dated April 15, 2011 ([Attachment 2](#)) signed by Ray W. Brewer, HUD Field Office Director in Los Angeles, clearly states “the requested documents are releasable without applying any exemptions.” The Commercial Requester was charged \$72.20 for the documents and it was noted that the requester’s identity and the information made available will be releasable to the public under subsequently received FOIA request.

The consequences of such a cover-up proposed by Edward Campbell could be devastating to our immediate community and pose a tremendous fiscal liability to the U. S. Taxpayers who are being asked to provide a “private” developer with a \$150 million dollar loan guarantee, that appears to be based on false information.

I also noticed the Los Angeles Office of HUD in letter dated May 2, 2011 ([Attachment 3](#)) of our concerns regarding the content of the FOIA Documents (Control No. 11-FI-R09-01387) but they have not responded or even acknowledged my letter. Your immediate investigation is urgently requested.
