COURT ORDER

On December 16, 2010, this matter was reassigned to Judge Robert O'Brien (Department 85) for all further proceedings. On January 7, 2011, Judge O'Brien denied a motion by Richard I. Fine to void the orders of Judge David P. Yaffe in this case.
