**NATURE OF PROCEEDINGS:**

It has been brought to the court's attention that its ORDER STRIKING NOTICE OF DISQUALIFICATION dated and filed March 27, 2008, refers to an earlier March 18, 2008 draft order that was not filed, rather than, as intended to the final order that was filed March 20, 2008, a copy which is available from the scanned documents for this case on the court's website, or from the court file. A copy is also transmitted herewith.

In addition, the March 27, 2008 order includes two matters from the March 18, 2008 draft that were not a part of the actual order filed on March 20, 2008; (1) a finding that Mr. Fine, not being party or a lawyer for a party, lacked standing to file a verified statement of disqualification; and (2) an advisement to the parties that the exclusive means of seeking review of the determination of the question of disqualification was a timely petition for a writ of mandate to the Court of Appeal pursuant to Code of Civil Procedure Section 170.3(d). The court did not intend to make any finding as to whether Mr. Fine had standing to file a verified statement of disqualification pursuant to Code of Civil Procedure Section 170.3. While there was not advisement in the court's March 20, 2008 order that Code of Civil Procedure section 170.3(d) was the exclusive means of seeking review of the determination of the question of disqualification, such an advisement was included in the court's March 27, 2008 order.


